



BASIC INSURANCE FOR TRAVEL, DIVING AND CANCELLATION SUMMARY OF COVER OF THE POLICY Nº 698/380 CONTRACTED BY BLUE FORCE DIVING

- 1. Medical transportation or repatriation, in case of the Insured suffering some disease or accident away from home, to a suitably equipped medical facility or to his/her habitual country or place of residence. Including the accompanying
- 2. Medical care (expenses related to hospitalization, surgical interventions, doctors' fees, nursing care and pharmaceutical products) in case of the Insured suffering some disease or accident while abroad (up to a maximum of € 60.000,00). In Spain (up to a maximum of € 1.500,00)
 - Expenses resulting from the hyperbaric chamber: up to a maximum of € 3.000,00
- 3. Transport and accommodation for a person accompanying the hospitalized Insured in case of disease or accident (resident in the Insured's habitual country or place of residence, to be chosen by the latter):
 - Transportation to place of hospitalization (return trip).
 - Accommodation: up to \notin 75,00/day, with a maximum limit of \notin 750,00, or ten days.
- 4. Prolongation of the Insured's stay away from home, in case of disease or accident, provided this is on doctor's orders (up to € 75,00/day, with a maximum limit of € 750,00, or ten days).
- 5. Transportation or repatriation of the Insured's remains and transport for the person (resident in the Insured's habitual country or place of residence) accompanying the corpse to the place of interment, cremation or funeral ceremony in the habitual country of residence.
- 6. Transport for the Insured where a trip is interrupted, due to the death of a relative within the second degree of kinship in the Insured's habitual country of residence.
- 7. Transport for the Insured where a trip is interrupted, due to an emergency at his/her habitual residence or professional premises.
- 8. Shipment of medication urgently prescribed by a doctor.
- 9. Transmission of urgent messages.
- Compensation for loss, theft or destruction in whole or part by all the baggage and personal effects billed during carriage by the carrier (up to maximum € 1.200,00).
- Indemnity for delays of over 6 hours, from the flight arrival time, in receiving luggage and personal effects duly checked-in (up to a maximum of € 200,00) in order to defray the costs of basic necessities.
- 12. Localization and shipment of luggage and personal effects to the scheduled destination or to the Insured's habitual place of residence (unlimited).
- 13. Travel Cancellation Expenses (up to a maximum of € 1.500,00).
- 14. Accidental death of the Insured, as a result of an accident in the transport medium (€ 60.000,00).
- 15. Private Liability Insured (up to maximum € 60.000,00).
- 16. Indemnity for interruption of the contracted trip (up to maximum € 1.500,00).
- 17. Arranging delivery of cash abroad (up to maximum \in 3.000,00).
- 18. Management costs for loss or theft of documents abroad (up to maximum € 240,00).
- 19. Delay in the departure of the contracted mean of transportation (up to maximum $\in 200,00$).
- 20. Loss of connections than 3 hours in the arrival of international flights to Spain (up to maximum \notin 600,00 \notin).
- 21. Loss of contracted services for delay of more than 3 hours in the arrival of the international flight to the final destiny (maximum € 200,00).
